Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of Central University of Rajasthan, Bandarsindri, Kishangarh (Ajmer) for the year ended 31 March 2022

We have audited the attached Balance Sheet of the Central University of Rajasthan (CURAJ), Bandarsindri, Kishangarh (Ajmer) as at 31 March 2022, the Income & Expenditure Account and Receipts & Payments Account for the year ended on that date under Section 19(2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 31(1) of the Central University Act, 2009. These financial statements are the responsibility of the Central University of Rajasthan's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (C&AG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/C&AG's Audit Reports separately.

3. We have conducted our audit in accordance with the auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

Based on our audit, we report that:

 We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.

ii. The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format approved by Ministry of Human Resource Development (MHRD), Government of India vide order No. 29-4/ 2012-FD dated 17 April 2015.

iii. In our opinion, proper books of accounts and other relevant records have been maintained by the Central University of Rajasthan, Bandarsindri, Kishangarh (Ajmer) as required in so far as it appears from our examination of such books.

Comments on Accounts:

A. Application of Funds

Balance Sheet of the University

A.1 Fixed Assets-Capital WIP-HEFA Loan Scheme (Schedule-4B): ₹ 16.40 crore

This includes unutilised balance of advances issued to Central Public Works Department (CPWD) for capital works amounting to ₹ 2.89 crore as on 31.03.2022. The amount was to be shown under Schedule-8: Loans, Advances & Deposits.

This has resulted in overstatement of Fixed Assets by ₹ 2.89 crore and understatement of Loans, Advances & Deposits by the same amount.

B. General

B.1 CURAJ had incurred expenditure on construction of various works/buildings. The same had been completed by the CPWD. However, CURAJ has neither capitalised these assets nor charged depreciation thereon.

This comment has also been raised in the SARs since 2016-17, but the irregularity persists.

C. Grant-in-aid

The CURAJ has received grant-in-aid of ₹ 51.67 crore (including refund of ₹ 2.60 crore by Public Health Engineering Department) during the year 2021-22. Unspent grant of ₹ 13.10 crore was available at the beginning of the year. Out of total available grant of ₹ 60.01 crore (excluding refund/pull back of ₹ 4.76 crore by University Grants Commission), CURAJ could utilise ₹ 49.50 crore (Capital expenditure: ₹ 3.64 crore and Revenue expenditure: ₹ 45.86 crore) leaving a balance of ₹ 10.51 crore at the end of the year.

D. Management Letter

Deficiencies, which have not been included in the SAR, have been brought to the notice of the Management through a management letter issued separately for remedial/corrective action.

v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report are in agreement with the books of accounts.

vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statement, read together with the Accounting Policies and Notes on Accounts and subject to the significant matters, stated above and other matters mentioned in Annexure to this Audit Report give a true and fair view in conformity with accounting principles generally accepted in India.

3. FIXED ASSETS AND DEPRECIATION

- 3.1 Fixed assets are stated at cost of acquisition including inward freight, duties and taxes and incidental and direct expenses related to acquisition, installation and commissioning of the assets. However, under the budget head "Site development of Land and Plaintation" the expenses incurred towards labour charges, JCB used for land development and expenditure incurred on fencing have been included in the cost and charged to Plantation and Site Development.
- 3.2 Gifted / Donated assets are valued at the declared value wherever available; if value is not available, the value is estimated, based on the present market value adjusted with reference to the physical condition of the assets. They are set-up by credit to Capital Fund and merged with the Fixed Assets of the University. Depreciation is charged at the rates applicable to the respective assets.
- Books received as gifts, are valued at setting prices printed on the books. Where they are not printed, the value is based on assessment. 3.3





(Amount – Rs. in Lacs)








Recurring Expenditures at a Glance

(Amount – Rs. in Lacs)





(Amount - Rs. in Lacs)




